# **KEEPING IN THE LOOP OPEN LOOP RECYCLING**

Open loop recycling is where the recycled materials are converted into both new raw materials and waste product using a different application and often into a longer life product.

Example: recycling HDPE bottles to make plastic pipes with a long lifespan keeping the recycled material in functional use.

The post consumer recycled material we use is processed in China and then shipped to Pakistan where it is then used to manufacture our ECOROKWEAR garments.

We are extending the lifespan of post consumer bottles by processing them into recycled materials for the garments.
